Known Hazards & Assumption of Risk

I understand that offshore sailing & expedition activities carry inherent risks that cannot be fully eliminated, including but not limited to:

- Ropes, winches, sails & deck machinery
- Storms, high winds & heavy seas
- Falling overboard or drowning
- Vessel collision, grounding or shipwreck
- Remote or delayed medical care & evacuation
- Wildlife encounters ashore or at sea
- Physical & emotional exhaustion
- Seasickness, illness or equipment failure
- Personal injury, emotional trauma or death
- Piracy (in applicable regions)

I voluntarily and knowingly assume ALL risks, known and unknown, and accept full personal responsibility for my safety during the trip.

Release of Liability & Waiver of Claims

In consideration of being permitted to participate, I hereby RELEASE, WAIVE, DISCHARGE, and COVENANT NOT TO SUE the Company from any and all liability, claims, demands, actions, or causes of action of any kind arising out of or relating to my participation, including claims resulting from the Company's own negligence, to the fullest extent permitted by applicable law. This release covers personal injury, illness, emotional trauma, death, and loss of or damage to personal property.

Guest Crew Responsibilities & Code of Conduct

- Always follow all safety instructions from the Skipper and professional team at all times.
- Inform the Skipper or Professional team immediately if asked to perform any task I feel unsafe or unqualified to carry out.
- Act at all times in a manner that ensures the safety and wellbeing of all persons on board. I will not take any action that endangers others or myself.
- Treat all crew members, fellow Guest Crew, and any persons encountered during the voyage with dignity and respect. I understand that physical, verbal, psychological, or sexual abuse or harassment of any kind will not be tolerated and may result in immediate removal from the vessel at my own expense and without refund.
- Maintain adequate personal travel and medical insurance covering offshore sailing, medical evacuation, pre-existing conditions, trip cancellation, and loss of personal property.
- Confirm that I am reasonably physically and mentally fit to participate. If in doubt, I will consult the Company before booking.

Governing Law & Dispute Resolution

This Agreement is governed by the laws of the State of Florida, USA. Governing law, arbitration, and dispute resolution are subject to the terms set out in the *Pangaea Exploration LLC Terms and Conditions*, which the Guest Crew confirms they have separately reviewed and agreed to at the time of booking and paying deposit.

Safety Briefing Certification

I confirm that, prior to departure, I received and understood a full safety briefing from the crew of Pangaea Exploration LLC, which covered the following:

- Man Overboard (MOB) procedures — alert signals, recovery positions, and crew roles
- Fire safety — location and use of extinguishers, fire blankets, and emergency shut-offs
- Ship abandonment drill — life raft, EPIRB, grab bag, flares, and abandon-ship signal
- Personal safety equipment — lifejackets, harnesses, tethers, and jacklines

I had the opportunity to ask questions and am satisfied that I understand the safety procedures applicable to this voyage.
